### **ORDER** (Oral)

The applicants have filed this OA, seeking the following reliefs:-

- "(a) the Respondents may kindly be directed to revise/calculate the rate and ward facility of the Applicants on or after retirement or in service, on the basis of current CDA pay corresponding to the last IDA Pay, on surrendering of MTNL medical facility by the applicants and grant the CGHS rate and ward entitlement accordingly.
- (b) any other further relief which this Hon'ble Tribunal deems fit and proper may also be given in favour of the Applicants and against the respondents."
- 2. It is the case of the applicants that they were transferred from DOT (respondent no.1) and absorbed in MTNL on 01.11.1998 and 01.10.2000. They have alleged that those employees, who were similarly transferred from DOT and absorbed in MTNL but had opted for option 'A', are allowed to avail CGHS facility at the rate and ward on the basis of grade pay of Central Pay Scales by converting to corresponding last pay on IDA from MTNL on which basis the MTNL medical facility were provided by the MTNL, whereas the applicants, who had

opted for Option B and had surrendered their MTNL medical facility after retirement, are allowed the CGHS facility on the basis of last pay drawn of CDA on 31.10.1998 and 30.09.2000. They have also submitted that similarly situated retired BSNL absorbees have also been allowed the facility of CGHS by the Ministry of Health & Family, Department of Health & Family Welfare, New Delhi as per the letter No.Z15025/36/2006-CGHS III (Part) dated 09.01.2014. Being aggrieved with this inaction of the respondents, they have submitted a number of representations but to no avail. Hence, the present OA.

The respondent, while contesting the OA, have filed 3. their reply in which they have stated that in the case of employees who were absorbed in MTNL and had opted for Option 'A' are being paid by the Government, whereas in the employee, who had opted for option B, the pensionary benefits were to be paid from the Pension Fund to be created for the purpose but due to the stiff opposition by MTNL employee Associations/Union, the pension fund required to be created for absorbed Group "C" and "D" employees could not be created. They have submitted that their demand for similar treatment for payment of BSNL pensionary benefits as given to absorbed

employees, have been accepted by the Government by making amendment in Sub-Rule (22) and (23) of Rule 37-A of CCS(Pension) Rules, 1972, thereby making provision for payment of pensionary benefits, including family pension to the absorbed employees of MTNL by Government.

4 They have contended that the applicants of the present OA have opted for Option B and are thus getting pro-rata pension from the Government for their services in Government before rendered their permanent absorption in MTNL as per the provision of DOP&PW's OM No. 4/18/87-P&PW(D) dated 05.07.1989. They have submitted that these employees are thus deemed to have retired from the Government service for which they are getting pro-rata pension as per CDA pay scale from the Government/Central Civil Estimates and while continuing with the employment in MTNL from which they were getting medical facilities as per MTNL policy on the subject. They have thus submitted that after their final retirement from MTNL, they were ceased to get medical facilities from MTNL and since they are getting pension from Government/Central Civil Estimate, they are entitled to avail CGHS facility on the basis of their last CDA pay drawn in Government service as on

31.10.1998 and 30.09.2000 before their permanent absorption in MTNL. They have thus prayed for dismissal of the OA.

- 5. The respondents in their CA have raised the objection that since these MTNL pro-rata pensioners earlier submitted representations in bulk against the disparity between them and the combined service pensioners in terms of CGHS entitlement/category, which is based on last pay drawn at the time of retirement, their request could not be considered as both the groups, i.e., MTNL pro-rata pensioners and MTNL combine service pensioners are different and therefore, no equivalence could be drawn.
- 6. After hearing both the parties and perusing the records, we find a number of representations placed at Annexure A/4 (colly) made by the applicants to the Secretary, DOT, Ministry of Communication & IT on the subject "Revision of category of entitlement of CGFHS facility in service/retirement which reads as under:-

"Secy - DOT

Ministry of Communication & IT,

Sanchar Bhawan, 20 - Ashoka Road, New Delhi

Sub-Revision of entitlement of CGHS facility in service/retirement.

Respected Sir,

It has the honor to make kind submission in reference to the annexure of letter of file no.4-12(11)2012-PAT(Part) issued by GOI, ministry of communication, Department of Telecommunication 31.08.2016 dated and vide no.MTNL/CO/MED/Retiree/CGHS/2016 dated 31.08.2016 issued by CO-MTNL, Delhi that the applicant is entitled for CGHS facility on the ground of PPO issued by Pr. CCA(DOT) and getting pension from the consolidated fund of India since absorption in MTNL 1/11/1998 & 1/10/2000. But on the surrendering of MTNL medical facility in service or on superannuation retirement from MTNL by the applicant, the category of CGHS is provided on the last pay drawn on the service of central govt., while those employee who are getting pensin from central civil estimates, are allowed the category of CGHS on CDA scale corresponding to the last pay drawn on IDA pay scale on the surrendering of MTNL medical facility on or after superannuation retirement from MTNL. The same is applied in BSNL for serving as well as retiree.

Sir, both employee's are absorbee of DOT in MTNL. This is the great discriminati8on with the applicant and violation of article 14 of constitution of India and against the natural justice. The applicant is to be allowed the category of CGHS facility on the corresponding of last pay drawn on IDA pay scale on retirement and current IDA pay scale is to be considered in case of serving absorbed who are getting PRO RATA pension for the service rendered to the central govt. on surrendering of MTNL medical facility. It is requested for sympathetical consideration for natural justice."

7. When it was asked from the respondents as to why they have not decided the aforesaid representations made by the applicants, they have submitted that the so called representations were never received by them. Even from perusal of the said representations placed on record, it is not made out that these were received by the

respondents, as they do not contain any signatures in proof of their receipt. It is also noticed that the representations placed on record are also undated.

- 8. In view of the facts and circumstances involved in the case, we direct the respondents to treat the representations filed in the OA as such and to consider each case of the applicants separately on the basis of their representations and pass a reasoned and speaking order within a period of 90 days of receipt of a certified copy of this order. In case they find a case made out for any revision of category of entitlement of CGHS facility in service/retirement, the respondents shall pass order accordingly revising their entitlement of CGHS facility.
- 9. With the above directions, the OA is disposed off.
