With reference to above cited subject, the list of employees to provide Assistance cum Help Desk for Enrollment in CGHS to MTNL Retired employees to fill up ONLINE CGHS form, is enclosed herewith.

These employees shall facilitate to fill up ONLINE CGHS FORM for MTNL Retired Employees till first week of September, 2018 or further order.

Any MTNL Retired employees may be allowed to approach any SM (Admn)/ Nearest MTNL GM Unit of his/her residence for ONLINE SUBMISSION and to issue Form No.2 (Certificate) for availing CGHS facility. No Retired MTNL employee should be refused for access to ONLINE submission to CGHS application form by any unit. **On issue of Form No.2 (Certificate) by any SM (Admn), retired employee shall not be extended MTNL Medical facility (IPD & OPD) and the copy of Form No.2 (certificate) may be forwarded to concerned SM (Admn) for record purpose.**

The pensioner has to pay Contribution to CGHS office as per the rate defined by CGHS. After payment of Contribution by Pensioners to CGHS, the Retired MTNL employee shall submit the self attested copy of Receipt/ Challan or any proof of premium amount issued by CGHS to **concerned DM (Cash/Works) i.e. last retirement GM unit, for avoiding payment duplication,** and to get refund of **50%* of the defined contribution for life time CGHS membership subject to minimum of Rs.20,000/- and maximum of Rs.40,000/-.**

In order to avoid the double/ duplicate payment, the concerned SM unit/ Accounts section should maintain register and make entry in WFMS for all CGHS card one time incentive reimbursement claim. The proforma for Reimbursement of Lifetime CGHS one time incentive to be submitted by retired employees to his/her **concerned DM (Cash/Works) i.e. last retirement GM unit only through concerned SM (Admn), is also enclosed herewith and retiree should surrender original Medsave/Insurance Co. Medical I-Card to concerned SM (Admn).**

“Once NOC for CGHS option is issued by MTNL, the retiree cannot revert back. The option of Insurance policy (CGHS) is available to only such retirees in whose case NOC for CGHS is not issued by MTNL”.

This may be treated as MOST URGENT.


