Sub:-Request to cause to issue orders on IDAs due from 01/07/2021 and 01/10/2021.

Pensioners of MTNL on combined service pension are paid Industrial Dearness Allowance which is revised quarterly on the basis of CPI(IW). Now on release of CPI indices, IDA @173.6% (increase of 3.1%) and further IDA @179.3% (increase of 5.7%) have become due from 01/07/2021 and 01/10/2021 respectively, but orders have not been issued by DPE so far. Prior to the freezing of IDA, orders on the quarterly rates of IDA were used to be issued by DPE in the first week of the month from which it takes effect. This is a decade old practice. Accordingly orders conveying the rates of IDA due from 1st July'2021 should have been issued in the first week of July'2021 itself and the orders on IDA due from 01/10/2021 are due to be issued in the first week of Oct'2021.

Therefore it is requested to cause to issue the orders immediately conveying the rates of IDA due from 01/07/2021 as well as from 01/10/2021 enabling the pensioners in their old age to cope with the inflation.
