Respected Madam,

Sub:-Request to cause to release IDAs which are due from 01/07/2021 and from 01/10/2021.

The Industrial Dearness Allowance based on CPI (IW) is payable quarterly to the employees of PSUs including the employees of MTNL who are on PSU Pay Scales. Pensioners of MTNL on combined service pension are also paid IDA. Prior to the freeze of IDA, the quarterly rates of IDA were used to be conveyed by DPE in the first week of the month from which it takes effect. This is a decade old practice. Accordingly the rates of IDA due from 1st July'2021 should have been conveyed in the first week of July'2021 itself. Now the subsequent quarter IDA from 1st Oct'2021 has also fallen due and the rates need to be conveyed in the first week of Oct'2021.

Therefore it is requested to cause to issue instructions to DPE to follow the decade old practice of promptness and also it is requested to cause to issue orders immediately conveying the rates of IDA due from 01/07/2021 and from 01/10/2021 as applicable to the different PSU Pay scales based on 1^{st} , 2^{nd} and 3^{rd} PRCs.
