Sincere Thanks to the management for relaxing the time limit of three months after retirement up to 31/12/2020 to join CGHS with MTNL subsidy for the pensioners retired from Dec'2019 to Aug'2020 on the grounds of lock down.

However the pensioners retired before Dec'2019 are disappointed as the facility to switch over to CGHS with the benefit of MTNL subsidy was not given to them. Every year this facility to switch over to CGHS was used to be given to all the existing pensioners coinciding with the period of submission of renewal applications to CGHIS. In this regard it is pointed out that MTNL would be saving the recurring expenditures on CGHIS premiums and OPD reimbursements if the CGHIS beneficiaries switch over to CGHS. The 50% subsidy on the CGHS life time contribution will mitigate the burden of pensioners in bearing the heavy amount of contribution and will be a catalyst to switch over to CGHS. It will be a win win situation for MTNL as well as for pensioners.

Therefore it is requested to consider the issue and to offer the facility to switch over to CGHS for a short period of about one month up to 31/12/2020.
