**SUB:- ISSUES OF MTNL PENSIONERS**

Pensioners of MTNL Mumbai are aggrieved due to the following issues. We request you to kindly spare some quality time amidst your busy schedule to solve these issues.

1. Granting the benefit of 73.8% IDA (additional 5% IDA) to the pensioners retired prior to 01/01/2018 :- It is learnt that the file is pending at MTNL Corporate Office for a couple of months. **We request your kind selves to settle this issue early as the Pensioners are frustrated due to abnormal delay and tossing of the issue between MTNL and DoT.**
2. **Payment of balance of Ex-Gratia to the VRS Pensioners. The assurance of the Government to pay 50% by 31/03/2020 is not fulfilled as about 31% only has been paid. We request your kind selves to arrange for payment of balance of about 70% by 31/05/2020.**
3. To provide adequate funds immediately for payment of GPF and Leave Encashment to VRS Pensioners and Superannuation pensioners on combined service. It is learnt that the investments of Trust funds could not be liquidated due to market fluctuations. **We request you to kindly take up the issue with DoT and arrange for funds.**
4. To provide funds immediately for payment of gratuity and CPF to the VRS Pensioners and Superannuation Pensioners who have opted for pro-rata pension.
5. Retention of BSNL quarters by MTNL Pensioners at Mumbai as per the terms of DOT Rules and on the same terms as applicable to BSNL Pensioners. :- **BSNL Maharashtra Circle is charging L.Fee including the last drawn HRA from MTNL pensioners for retaining the BSNL Qrs for the permissible period. We request you kindly cause to**

amend the policy of BSNL for recovering L.Fee from MTNL Pensioners as per DoT rules..

6. Many localities in Mumbai are containment areas and it is not practical for the pensioners in occupation of the Quarters to find out alternate accommodation nor to arrange for shifting after the permissible retention period. Therefore we request your kind selves to extend the permissible retention period up to 31/12/2020 and to reintroduce “Leasing of quarters to pensioners” on reasonable concessional terms afterwards.
7. There are a few superannuation pensioners whose pension has not been settled as the case for waiver of training requirement for their financial upgradation is pending at Corporate Office. We request your kind selves to cause to issue orders waiving the training conditions.
