Respected Sirs,

The following issues were discussed by this Association in the meeting on 22/11/2022 with ED with the participation of GM(A) and GM (Fin).

We are thankful to the initiatives taken by Admin and Finance wings regarding all these issues and for referring these issues to the Corporate office. However No response seems to have been received from Corporate office so far. The issues are as under :-

1. Payment of arrears of ex-gratia to the VRS pensioners in the following cases a) after considering their training period for Qualifying service: b) after counting the temporary service of the then canteen employees: c) after retrospective financial upgradation. As per DM (Pen) letter dated 05/12/2022 addressed to DGM(Fin) MTNL Mumbai, 137 cases have been referred to CO for raising claim with DoT for funds and 37 cases are still to be processed.
2. Payment of interest for the period of delay in GPF final Payment to the pensioners retired since 2017. Finance wing has written a couple of letters to CO for funds.
3. Settlement of about 185 medical bills (mostly floater cases) submitted by the pensioners covered under CGHS during 2016-17
4. Option to switch over to CGHS with MTNL subsidy.
5. Restoring the erstwhile facility of reimbursement of OPD medical claims to those pensioners who are neither enrolled in CGHS nor in CGHS.
6. Restoration of stepping up of pay of six pensioners retired from PS cadre. No response is received from CO.
