It is requested to look into the above mentioned subject. The issue in brief is as under :-

As per the DoT's Memo No.11-1/2009-SU-II dated 19/06/2018, the benefit of 73.8% IDA in the fitment for revision of pay on 01/01/2007 with payment from 01/01/2018 was given to the MTNL employees. Consequently the pensioners retired after 01/01/2018 have got this benefit in their pensionary benefits. The same benefit should have been extended simultaneously to the pensioners retired prior to 01/01/2018 also, the reason being that discrimination between the pensioners retired before and after 01/01/2018 is not tenable.

This issue is pending at the office of DoT since last two and half years for some reason or other. Associations hold the view that the entitlement of the pensioners is absolute and hence this abnormal delay is not valid. Due to this inordinate delay, the pensioners are frustrated. It is sad to observe that every day a few pensioners are passing away without getting this entitled benefit.
