### SUB:- Request for Extension of time limit to submit Life Certificate

REF:- 1. DoT's letter No.47-15/TA-II/CPMS/2018/Part-I dated 19/05/20, 23/07/20 and 20/10/20

2. DoP & PW' OM No.18/1/2020-P&PW(H)-Vol-III dtd 11th Sep'20 and 23rd Nov'20

The timeline for submission of Life Certificate by Pensioners has been extended upto 28<sup>th</sup> Feb'2021 by Dept of P&PW vide OM dated 23<sup>rd</sup> Nov'2020. The reason for this extension as mentioned in the said OM is "in view of the ongoing Covid-19 pandemic and the vulnerability of the elderly population to Corona virus." Further it has been mentioned in the said OM that "the above measures (extension) are expected to avoid rush at branches, stagger the submission of the LCs by the elderly population while maintaining social distancing, and to that extent, prevent the spread of Coronavirus."
