The timeline for submission of Life Certificate by Pensioners has been extended upto 28<sup>th</sup> Feb'2021 by Dept of P&PW vide OM dated 23<sup>rd</sup> Nov'2020. The reason for this extension as mentioned in the said OM is "in view of the ongoing Covid-19 pandemic and the vulnerability of the elderly population to Corona virus." Further it has been mentioned in the said OM that "the above measures (extension) are expected to avoid rush at branches, stagger the submission of the LCs by the elderly population while maintaining social distancing, and to that extent, prevent the spread of Coronavirus."

The aforesaid reasons hold good for all the pensioners including MTNL pensioners. Therefore in synchronisation with the said OM, it is requested to cause to extend the timeline for submission of Life Certificate up to 28/02/2021 for the MTNL pensioners who are due to submit life certificate up to 31/01/2021.
