## SUB:- Request for Extension of time limit to submit Life Certificate

This Association requested Member (Fin) vide letter dated 09th Sep'2020 to cause to extend the time limit for submission of Life Certificate till the situation becomes normal for senior citizens too move out. Subsequently Department of Pension and PW extended the time limit upto to 31/12/2020 vide it's letter dated 11<sup>th</sup> Sep'2020. Pensioners of MTNL Mumbai felt relieved presuming that these orders of Department of P&PW are applicable to them also. However to their utter shock pension for Sep'2020 has not been drawn for about 425 pensioners on the pretext that they had not submitted Life Certificate.

Sir, Mumbai is one among the worst affected Cities due to Covid-19 and many localities are still under containment. It is the directives of the Government that senior citizens should not move out. In this environment about 15 thousand MTNL pensioners at Mumbai are due to submit Life Certificate in the months from Sep'20 to Nov'20. There are thousands of pensioners residing in suburbs who don't have any Digital Life Certificate Centre nearer to their residence.
