Sub:-Request to remove the discrimination which has arisen due to DoT's memo dated 19<sup>th</sup> June'2018 granting 5% additional IDA neutralisation only to the employees on role on 01/01/2018 in exclusion of the pensioners on role on 01/01/2018.

It is requested to kindly look in to this long pending issue which is dragging on for nearly about four years due to typical bureaucratic delays.

It is regretted to point out that despite the Associations' continuous pursuits for about three and half years, the aforesaid issue remains unsettled resulting in deprival of the legitimate dues to the MTNL pensioners retired prior to 01/01/2018. It is most unfortunate that, this abnormal delay is due to shunting of the issue between DoT and MTNL.

Most of the aggrieved pensioners are very senior citizens of more than 65 years old. They are frustrated due to this abnormal delay on the part of MTNL and DoT in removal of this untenable discrimination. Moreover it is pathetic to note that daily a few pensioners are leaving for heavenly abode due to old age without getting this benefit.

Therefore it is requested to cause to give utmost priority in handling this issue so that this long pending issue is settled early removing the discrimination and alleviating the agony of MTNL pensioners retired prior to 01/01/2018.
