Polite Reminder-1

Respected Madam,

Sub:-Request for Re-fixation of pension of absorbed MTNL employees retired within 10 months from 01/10/2000 by removing anomaly in the calculations of average emoluments. Ref:- DoT's letter No.38-16/2014-Pen(T) dated 7<sup>th</sup> Oct'2021

Ref:- Co-Ordination Committee's letter dated 03<sup>rd</sup> Nov'21 sent by email dated 04<sup>th</sup> Nov'21

Instructions have been issued by DoT vide letter cited under reference to remove the anomaly in the calculations of Average Emoluments of the ex-BSNL absorbed employees retired within the period of 10 months from 01/10/2000 and to re-fix their pension.

Similar anomaly exists in the cases of ex-MTNL absorbed employees who have retired within the period of 10 months from 01/10/2000. The anomaly of BSNL pensioners has been removed vide the reference cited above, but there is no mention about MTNL Pensioners in the said reference, although the anomaly is identical.

Therefore it is requested to remove the identical anomaly in the calculations of Average Emoluments of MTNL Pensioners on combined service retired within 10 months from 01/10/2000 and to re-fix their pension from their date of retirement.
