Sub:- Pension Revision of MTNL/BSNL retirees on the basis of 7th CPC fitment factor.

Ref:- This Co-Ordination Committee's letter dated 9th Nov'2021, and dated 18th Jan'2022

This is in continuation of aforesaid references. Associations approached officers of DoT many times regarding pension revision. During those meetings DoT officers raised two queries viz., 1. which rule provides for pension revision of MTNL/BSNL pensioners and 2. How to settle the anomaly of imbalance between the revised pension of those retired before 01/01/2017 and the pension of those retired after 01/01/2017 (if there is no corresponding pay revision).

In this regard we once again reiterate that the Rule 66(1) of CCS Pension Rules'2021 provides for pension revision. The anomaly can be settled by applying the same fitment factor of 2.515, (Basic pension 1 plus IDA of 1.195 on 01/01/2017 plus 0.32 the fitment derived from 7th CPC) on the pension of those retired prior to 01/01/2017 as well as on 50% of basic pay of those retire after 01/01/2017 without considering any pay revision. This will remove all the anomalies.

Therefore it is requested to send a concrete proposal for pension revision on the above lines to DoP&PW in response to it's letter dated 08th Mar'2019.
