Sub:- Pension Revision of absorbed MTNL/BSNL retirees on the basis of 7th CPC fitment factor.  
Ref:- This Co-Ordination Committee's letter dated 9<sup>th</sup> Nov'2021

This is in continuation of this Co-Ordination Committee's letter referred to above in which we emphasised to delink the pension revision from the pay revision of the employees. Subsequently 'The CCS Pension Rules'2021' has been published in the Gazette on 20<sup>th</sup> Dec'2021. **Rule 66(1) of the said rule provides for pension revision even otherwise than implementing the orders on CPC. This opens up the window for pension revision delinking it from pay revision as well as to derive a justified fitment factor.**

**MTNL/BSNL Pensioners demand that the fitment factor for pension revision should be derived from the fitment factor of 7<sup>th</sup> CPC adjusting it to the IDA on 01/01/2017.**

**Therefore it is requested to send a concrete proposal for pension revision on the above lines to DoP&PW in response to it's letter dated 08<sup>th</sup> Mar'2019.**
