#### Sub:-Request to cause to release the frozen IDAs with payment of arrears to Pensioners.

Recently, Government has announced that the Dearness Allowance to Central Government Employees / Pensioners will be released from 01/07/2021. But there is no mention about the release of IDA to the employees of CPSEs and to the Pensioners of MTNL / BSNL.

In the DPE's OM dated 19<sup>th</sup> Nov'2020, the IDA is frozen to the Executives of CPSEs; but there is no mention about it's applicability to the Pensioners. Though there are no orders to freeze the IDA of pensioners, it has been frozen to the pensioners of BSNL and MTNL

Therefore it is requested 1) to cause to unfreeze the quarterly instalments of IDA which are due up to 01/07/2021 and 2) to pay the released IDAs with arrears to the pensioners of BSNL/MTNL as the IDA to them has been frozen without any orders of the Government.
