

ORDER

Subject: - Review of Regular Promotions issued against the Regular CPC dated 30.06.2009 in the grade of DE(T)/SM(T)-reg

Competent Authority has accorded the approval for co-opting the seniority list of BSNL in MTNL, to bring the uniformity in the seniority of such TES Group B-DoT recruited officers absorbed in the services of MTNL/BSNL. In furtherance thereof, MTNL has issued the provisional seniority lists of MTNL officers vide Letter No. 15/18/3/2021-HR-Part(4)/1027 dated 01.03.2023 considering following 3(three) judgments at par with BSNL.

- i. Hon'ble Supreme Court judgment dated 21.01.2015 & 14.12.2017 in Civil Appeal No.4389 of 2010 in the matter of Union of India vs Sohan Lal Sayal & Ors.
- ii. Hon'ble Supreme Court judgment dated 12.12.2017 in Civil Appeal No.392/2017 in the matter of K S Hegde vs Union of India & Ors.
- iii. Hon'ble Supreme Court judgment dated 12.08.2014 in Civil Appeal No.7830/2014 in the matter of BSNL & Ors vs S K Dubey & Ors..

2. Revised seniority lists of BSNL was co-opted by MTNL, and MTNL has revised the TES Group B Seniority list earlier issued vide no. MTNL/CO/Pers-II/SDE Seniority/2009/761, dated 05.02.2009 and issued final Seniority list vide no. MTNLCO-15/18/3/2021-HR-Part(4)/1043, dated 08.06.2023, which is the basis of Review CPC.

3. Review CPC has been conducted as per Original CPC held in MTNL (2009, 2011, 2013, 2016 and 2018) and Consequential benefits (if any) will be payable only w.e.f 01.01.2018 and not for the past, in terms of the Hon'ble Supreme Court judgment dated 21.01.2015 & 14.12.2017 in Civil Appeal NO.4389 of 2010 in the matter of Union of India vs Sohan Lal Sayal & Ors as given below:

21.01.2015 Judgment of Hon'ble Supreme Court :

- "Restoration of the Seniority Lists 1 to 17;
- Appointment of Expert Committee to balance the rights of both the groups."

14.12.2017 Judgment of Hon'ble Supreme Court :

"7. We do not consider it necessary to pass any further order on above recommendations except that 14 persons who are said to have been given promotions – 3 persons in the BSNL and 11 persons in the MTNL contrary to the law laid down by this Court in (1997) 10 SCC 226 (Supra) may not be now disturbed. Their promotions and seniority may be considered personal to them without their being treated as class or a precedent for future. The judgment of this Court in (2015) 12 SCC 360 (Supra) will be treated as final between the parties on the principal of seniority.

8. We, however, make it clear that no arrears will be payable in terms of the impugned judgment. Consequential benefits of pay fixation including the Pensionary benefits, if any, will be payable in terms of the impugned judgment only w.e.f. from 01.01.2018 and not for the past."

4. First CPC for regular promotion in the grade of DE(T)/SM(T) was held on 30.06.2009 for 393 SDEs(T) and promotion orders were issued for FIT Executives vide letters nos. as below:

- i. No. MTNL/CO/Pers-II/SDE-DE Prom./2005-06/1023, dated, 01.08.2009
- ii. No. MTNL/CO/Pers-II/SDE-DE Prom./2005-06/1664, dated, 05.04.2010
- iii. No. MTNL/CO/Pers-II/SDE-DE Prom./2005-06/1023/258, dated, 30.05.2011
- iv. No. MTNL/CO/Pers-II/SDE to DE Promotions/2008/641, dated, 20.07.2013 and some more individual orders.

5. Review CPC has recommended 383 Executives (SDE-T) for the promotion in the grade of DE(T)/SM(T) on 11.07.2023 after the collection of ACRs/APARs, VC etc. of the relevant period from Delhi/Mumbai units.
6. Approval of the competent authority is hereby conveyed for the following:
- 254 Executives (Annexure-I)** were already promoted on 01.08.2009 & subsequent dates, w.e.f 30.06.2009 and as such, there is no change in the dates of their promotion to DE(T)/SM(T) grade.
 - 16 Executives (Annexure II)** were promoted on 01.08.2009, and as such there will be no change in the dated of their promotion to DE(T)/SM(T) grade- protection extended in the Hon'ble Supreme Court order dated 14.12.2017/21.01.2015.
 - 35 Executives (Annexure-III)** were never promoted in the original CPCs and these are recommended for notional promotion w.e.f **30.06.2009**.
 - 78 Executives (Annexure-IV)** were promoted in the original CPCs held in year 2011/2013/2016 and these executives are recommended to **prepone the promotion date** i.e. notional promotion w.e.f 30.06.2009.
7. The Promotion Order is issued after obtaining the Vigilance Clearance from MTNL, Delhi/Mumbai Unit and is further subject to the following conditions:
- The Officer(s) had been permanently absorbed in MTNL.
 - No Disciplinary / Vigilance case is pending against the Officer(s) or Vigilance Clearance is withheld in terms of instructions contained in GOI (DoP&T) OM No. 22011/4/91-Estt. (A) dated September 14, 1992 as on 30.06.2009.
 - Currency of penalty, if any, against the Officer(s) was over as on 30.06.2009.

8. Further action regarding pay fixation, pension revision etc. may please be taken by the respective units as per directions of Hon'ble Supreme Court detailed at para 3, above.

8. Further action regarding pay fixation, pension revision etc. may please be taken by the respective units as per directions of Hon'ble Supreme Court detailed at para 3, above.
