SUB:- MEDICAL FACILITIES OF PENSIONERS

At the outset we thank your good selves for reopening the scheme of 50% reimbursement of life time subscription of CGHS for two months up to 31/08/2018. We got feedback from our members and our views regarding "Policy on Medical facilities to Pensioners" are as under :-

1. Pensioners of MTNL, Mumbai are scattered throughout India. The CGHS is present in only about 25 cities. In Mumbai too the coverage of CGHS is quite inadequate. Due to this reason about ten thousand pensioners of MTNL Mumbai have joined CGHS in the current year. **Therefore, it is requested that CGHS should continue for the next term of two years from 01/10/2018.**
2. **Fixed Medical Allowance does not provide for hospital treatment. So even if FMA is introduced, CGHS should continue.**
3. Dy. Director CGHS holds quarterly formal meeting with all the Pensioners Associations and our Associations participate in those meetings and continuously pursue to open more wellness Centres. **It is requested MTNL should let out space to CGHS at concessional rate of rentals enabling to open more Wellness Centres, so that more and more pensioners will be encouraged to opt for CGHS.**
4. At present the time limit to apply to CGHS by new retirees under the scheme of 50% reimbursement of life time subscription is three months from the date of retirement. **It is requested that the time limit should be reckoned from the date of actual receipt of PPO instead of date of retirement in view of delay in getting the PPO.**





5. The scheme of 50% reimbursement of life time contribution to CGHS is now open up to 31/08/2018 for the existing pensioners. It is requested that the scheme should be kept open without time limit as MTNL will be benefitted by recurring savings on expenditures on medical facilities whenever the pensioner opts for CGHS. Alternatively, it is requested to consider 100% reimbursement of lifetime contribution as one time measure to induce all the pensioners to join CGHS.
6. It is requested to settle the pending medical claims under CGHS pertaining to previous years early.
