CIRCULAR

Sub: - Staggering of Verification of 'Life Certification'.

As special measure and to mitigate the hardship of the MTNL Pensioners & Family Pensioners, DOT has allowed staggering of Life Certificates to MTNL pensioners whose pension is being disbursed directly by CCA Mumbai.

The Salient features of this measure are as follows:

- 1. The Staggering of 'Life certification' will begin w.e.f. 01st April 2019**
2. Pensioners (Superannuation/Voluntarily retirement and converted family pension) will submit the Life Certificate manually or online (Jeevan Pramaan) in the corresponding/respective month of retirement.
3. Direct Family pensioners will submit the Life certificate manually or online (Jeevan Pramaan) in the month of death of Employee.
4. If the Pensioner/Family Pensioner fails to submit the Life certificate in their corresponding month; they can submit the Life Certificate manually or online as per their convenience before 31st October 2019. Life certificate will remain valid for next 12 months. For e.g. If pensioner submit the life certificate in April 2019 it will be valid up to 31st March 2020.
5. **For the current year Life Certificate done in November 2018 is valid till 31st October 2019. But for pensioners who retired in the month of November 18 to March 19 are requested to submit their Life certification before 15th November 2019.**




6. Life Certificate is to be done before 15th in due month. For example, if a Life Certification is due in the month of April, the pensioner should submit his Certification before 15th April to enable this office to draw his pension. If the pensioner fails to submit his Certification on or before 15th, the pension for April would be drawn in the following month i.e. May along with arrears.


