We are thankfully aware of the sincere and painstaking efforts taken by DOT and the Office of the Principal CCA, Mumbai as well as proactive role played by the CMD/MTNL and MTNL Mumbai to ensure that the pensioners of MTNL who retired prior to 31.3.2014 receive pension from Principal CCA, Mumbai on the basis of the list and figures provided by MTNL without issuing PPO books by DoT.

However the work of preparation of PPOs who retired prior to 31/03/2014 is not progressing. Not even a single PPO has been issued so far. No doubt it is a voluminous work. Carrying out this work on a systematic way seems to be wanting.
