Sub : Clarification regarding commutation of pension after the implementation of recommendation of 6th CPC.

Ref : Letter No.MTNL/CO/IRW/21(12)/2007/62 dated 03/03/2011 of Jt. GM(HR) endorsed by CAO(FC) vide No.FC/MUMB/Pension 6th.CPC/10-11 dated 11-03-2011.

1. Kindly refer to the letter cited above. As per Government of India decision No.1 under Rule 10 of CCS (Commutation of Pension) Rules, 1981 the reduction from pension will be made from the date of receipt of the revised commutation value of pension by the pensioner or three months after the issue of authority by the Accounts Officer asking the pensioner to collect the revised commuted value of pension whichever is earlier. Kindly therefore arrange to make the arrears of pension from the date of retirement to the date of receipt of second commutation of pension for those retired employees who have retired on or after 01.01.07 and for whom the payment of second commutation has been made due to II IDA Pay implementation.

2. Original commuted portion of pension will be restored after fifteen years from the date of retirement. The date of second restoration of commuted portion of pension will be 15 years after the date referred to at para 1 above.

3. The pension disbursing unit will issue an order for restoration of commuted portion of pension after getting an application from the pensioner in the proforma enclosed and after verifying the payment details of the commuted value of pension recorded in the PPO.

4. After payment of commuted value of pension the disbursing unit should send intimation to the PPO issuing authority. On restoration also, the copy of order restoring the commuted portion should be sent to the pensioners as well as to the PPO issuing authority by the pension disbursing unit.

5. This issues with the approval of the General Manager (Finance).
