Sub:-Request to implement the judgement of Pr. CAT Delhi in OA No.1271/2020, OA No. 1272/2020 and OA No. 1329/2020 reg. revision of pension and family pension of retirees from MTNL/BSNL on combined service wef 01/01/17 applying 7th CPC fitment factor.

At the outset the pensioners of MTNL Mumbai sincerely wish you to have a successful and shining stint in your present assignment.

The pension and family pension of MTNL/BSNL Pensioners is due for revision with effect from 01/01/2017 after the last revision 10 years ago. The Associations of MTNL and BSNL are pursuing this issue since 2018 after implementation of 7th CPC recommendations regarding pension to Central Govt Pensioners.

There was stalemate in the talks during 2020 and the the Associations had no other go at that time except to resort to filing cases in Pr.CAT Delhi praying to direct DoT to implement pension revision as applicable to CG Pensioners. **Our Association is an Applicant in OA No.1271/2020.**

On hearing, Pr. CAT Delhi has accepted our plea in toto and pronounced the judgement orders on 20/09/2023. Para 28 of the operative portion of the said orders says "...the OA stands allowed....... that the benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the Pay Commission, shall stand extended in favour of the applicants, analogous to the revision of such pension in case of Central Government pensioners.". Further Para 29 of the said orders says that "the directions contained herein shall be complied with within a period of 10 weeks from the date of receipt of a certified copy of this orders."

The anxious loud voice of about 4,50,000 (four and half lakh) pensioners of MTNL and BSNL and their families for implementation of the aforesaid judgement is echoing from all the corners of the country. We, the four and half lakh pensioners, are waiting for more than 6 years for their pension revision. Therefore our Association fervently requests your judicious self to cause to implement the
