**Sub:- Pension Revision of retirees from MTNL/BSNL on combined service in implementation of PCAT judgment dated 20/09/2023.**

DoT informed the Associations in the informal meetings that Pension Revision issue has been referred to DoE with a few proposals for revision. Now it is learnt that DoE has returned the file with the following opinions :-

- ❖ DoT should send only one concrete proposal to DoP&PW.
- ❖ On such proposal DoP&PW will take a policy decision in consultation with DoE.

In this regard it is requested to recall the following facts. On the issue of pension revision, five years ago, DoP&PW in it's letter dated No.4/02/2019-P&PW (D)/40504 dated 08/03/2019 requested DoT as under :- **"....the issues raised in the representation dated 12/02/2019 from Committee of BSNL / MTNL Pensioners' Associations (CBMPA) may be examined by DoT, and the comments of DoT thereon, may be sent to this Department along with the clarifications sought in this Department's ID note dated 14/01/2019"** The following information was also called for by DoP&PW in the said letter :-

- ❖ What would be the formula for revision of pension of those retired prior to 01/01/2017.
- ❖ What would be the financial implications on pension revision as per that formula.
- ❖ How it is proposed to resolve the anomaly in pension of those retired after 01/01/2017 in view of BSNL/MTNL's un affordability for pay revision.

The CBMPA and it's constituent Associations took up the issue many times with DoT requesting to respond to the letter dated 08/03/2019 of DoP&PW, but DoT did not comply with.
