With reference to above letters of DOT HQ and Pr. CCA Mumbai on the subject, it is intimated that RBI has allowed the 3 private banks (HDFC Bank, Axis Bank and ICICI Bank) to conduct government agency business which includes pension disbursement. This arrangement is in addition to bank accounts held with Public Sector Banks for the purpose of pension disbursement.

In this regard, it is instructed that any Combined Service Optee retiree submits the Bank Account details for pension with 3 private banks (HDFC Bank, Axis Bank and ICICI Bank); the same may be accepted and forwarded to O/o Pr. CCA Mumbai for pension disbursement. If any existing pensioners wants to change their pension account to these banks, they can submit the request alongwith ECS Mandate available as Sl. No.19 on website pensioner.mtnl.in to AO(PDA), O/o Pr. CCA Mumbai directly.



I am directed to inform that 3 private banks (HDFC Bank, Axis Bank and ICICI Bank) have been authorized by RBI to conduct government agency business which includes pension disbursement. Therefore, in addition to bank accounts held with Public Sector Banks, Pr. CCA/CCA offices may accept bank account details submitted by pensioners having accounts with the 3 private banks (HDFC Bank, Axis Bank and ICICI Bank) for the purpose of pension disbursement.
