Sub:- Request for intervention to cause to settle the retirement dues of Superannuation and VRS Pensioners of MTNL

Our Associations are left with no other alternative except to seek your intervention as the retirement dues are not settled despite our continuous requests to all the authorities. The following dues are pending for a long time.

GPF, CPF, Leave Encashment, MTNL Gratuity etc.,:-

Pensioners on Superannuation and on VRS have not been paid these retirement dues either fully or partly since Jan'2020 onwards. Some left over pensioners retired prior to Jan'20 have not been paid. **MTNL is struggling to arrange for funds to pay these dues. Therefore some special arrangements are required to provide funds to MTNL to settle the dues of the pensioners.**

Ex-Gratia compensation to VRS Pensioners :-

In compliance to the decision of the Union Cabinet on 23/10/2019 as communicated vide DOT's OM. F.No.30-04/2019-PSU Affairs dated 29/10/2019, the ex-gratia money should have been paid in full by 30/06/2020 itself. However, even after a lapse about six months from this assured date, about 8% of the ex-gratia money is still to be paid. **This inordinate delay in payment of ex-gratia beyond the assured date by the Government, sorry to say Sir, is lowering the credibility of the assurances of the Government.**
