Since the process has been done out of WFMS system, the manual accounting entries will be done centrally and ATs will be raised to units. The units may update the recovery schedule and necessary certificate may be issued wherever required. The salient features of the Final installment Exgratia payment are as below:

1. The total VRS-2019 retirees are 8193 and Exgratia payment processed for 8141 retirees. The balance 52 retirees whose strike off order issued provisionally, pension forms not submitted and cases not settled due to administrative/pay fixation issues are not considered.

- 2. The 77 cases out of 8141 retirees are reported expired after 31-01-2020, where the payment will be released to nominees. The sanctions and funds are allotted to the concerned units vide letter at Ref. no. 2.
- 3. The recoveries made from the Exgratia are as per the inputs given by the P&A units, in case of any excess/wrong deduction; refunds may be settled at unit level.
- 4. As per the WFMS, few retirees are paid excess CGHS reimbursement amount, the same has been recovered from Exgratia. In case of any retiree already returned the same to MTNL, the recovery made from the Exgratia may be refunded at the unit level.
- 5. The society dues recovered as per the inputs received from the MTNL Credit society.
- The TDS has been deducted as per Old Tax Regime on payable Exgratia amount with consideration of excess tax deducted in Leave Encashment due to DOT leave period exemption wherever units has corrected in WFMS.
- 7. The Final installment calculation sheet will be made available on portal "pensioner.mtnl.in" in due course. In case of any queries from retirees may be settled at the unit level.
- 8. In case of non receipt of payment, the retirees may be asked to approach AO (Cash) HQ on 022-24312999.
