With reference to above letter, VRS-2019 CSO retirees will be paid deferred gratuity with interest as per prevailing GPF rates on attaining the superannuation.

In this regard, it is observed that the pension cases of VRS-2019 retirees whose superannuation falling upto May-2020 are still not submitted by some units and in some other cases objections raised by CCA unit are not complied and resubmitted. The list of such cases is annexed for reference.

Secondly, the regular superannuation cases from Jan-2020 to May-2020 may also be reviewed at unit level and submitted to CCA, Mumbai immediately to avoid any grievance.

It is requested to bestow personal attention in the matter and necessary steps may be taken for submission of these cases immediately to avoid any further grievances from the retirees.
