Sub: Provision pension under Rule 64 of CCS Pension Rules, 1972 for the Officers who retired and pension case not settled due to financial upgradation mandatory 2 weeks training not completed.

Ref: 1. MTNL/CO/Pers-II/Prom Pol-Exec./07 dated 11-09-2007

As per the Executive Time Bound IDA Scale Up-gradation policy Clause I (f), the executive who is in receipt of financial upgradation has to undergo compulsorily 2 weeks of training for being eligible for drawal of SECOND increment in the upgraded IDA Scale i.e. training is to be completed within a period of two years from the date of the upgradation to the higher scale. Further, the Executives who fails to complete the prescribed two weeks training successfully will not be eligible for consideration of next IDA scale upgradation even is he/she is due for upgradation otherwise.

The CCA, Mumbai unit has pointed out in some cases that the retired Executives who are upgraded in higher IDA scale had not completed the compulsory two weeks or any one week training and received regular increments in upgraded IDA scale and even the next higher IDA scale upgradation. The matter has been referred to MTNL CO by the GM (Admn), Mumbai unit for the one time exemption for such cases and decision is still awaited. Since the retired Executives have been deprived of the retirement benefits including pension, the retirees have applied for the provisional pension under Rule 64 of CCS Pension Rules, 1972. The units have referred the matter to this office with query that on what basic pay the provisional pension should be processed.

The matter has been examined in consultation with GM (Admn), Mumbai unit and it has been decided as below.

"The retiree who has not completed the compulsory 2 weeks or any one week training of upgraded Time Bound IDA scale, that financial upgradation order to be treated as kept under abeyance and previous pay in the substantive grade/post will continue till retirement with regular yearly increments. In case, Executive has received Regular Post based promotion under policy, the notional fixation will be considered to arrive the basic pay for the provisional pension from time to time. The provisional pension under Rule 64 of CCS Pension Rules, 1972 may be sanctioned by the Head of the Office on such arrived Last Basic Pay as per the sub-delegation of financial powers order no. MTNL/FC/IF/2014-15 dated 17-06-2014 till the issue is settled by the CO. Further, the provisional pension sanctioned will be subject to submission of undertaking by the retiree about accepting the reduced provisional pension and recovery of any excess payment can be made from the

retirement benefits or will remit the same to MTNL/DOT as the case may be due to this arrangement. Since the Executive Time Bound IDA Scale upgradation promotion policy is notified on 11-09-2007, any IDA scale upgradation effect date is prior to 11-09-2007, those upgradation orders will not be affected."
