Sir/Madam,

It is to mention that India has been under lockdown since 25th March 2020 for 21 days. Also, Senior citizens like pensioners are, in particular, vulnerable to Covid-19. For generation of Life Certificate(LC), pensioners have to go to either a physical office (physical LC) or Aadhaar center/CSC (Digital LC) which will be against the spirit of Lock down. So, as a special measure for the pensioners ,whose LC is expiring on 29th Feb 2020 and 31st March 2020, it has been decided that

(i) pension be paid till month of April 2020 and the LC has to be submitted before 31st May 2020 failing which pension shall be stopped.

(ii) This may be communicated to pensioners via mobile SMS.

(iii) CCAs should make effort to obtain Life certificate from pensioners prior to that.

This issues with the approval of Member(F).
