Sub: Regarding clarification sought by Mumbal Unit whether 50% reimbursement for lifetime membership of CGHS has to be paid to retired employees who paid CGHS contribution for the period 1.01.2021 to 30.06.2023 after closure of CGHS window.

a) CO office order No.MTNL/CO/Medical/Retirees/CGHS/2016-90 dated 16.11.2023.

b) Mumbai Unit's email dated 29.02.2024.

With reference to above, it is informed that Competent Authority has accorded it's approval for following:

- 1. Granting 50% reimbursement for CGHS lifetime membership to all old/regular retirees.
- 2. Benefit of enhanced CGHS reimbursement i.e. minimum Rs.30,000/- and maximum Rs.60,000/- will allowed to only those retirees who have submitted their application for reimbursement after the date of issue of CO office order dated 16.11.2023 For all remaining retirees who have submitted their application for reimbursement for CGHS lifetime membership prior to 16.11.2023, shall be eligible for CGHS reimbursement with minimum of Rs.20,000/- and maximum Rs.40,000.
- 3. Admin section may be advised to issue instructions (three months prior to retirement), to all eligible prospective retirees, through their administrative controlling units, to submit their applications for availing CGHS facility after retirement. So that such retirees drawing Government pension can avail benefit of CGHS facility from the first day of their netirement.
