This is reminder to our letters dated 28th May'2025 and 17th June'2025. We respectfully seek your personal intervention. Earlier, DoT had intimated vide letter dated 05/11/2021 that **".. any decision in the matter is yet to be finalised"**. MTNL CO requested DoT vide letters dated 12/05/22 and 24/07/2024 that **'.....to implement 5% IDA merger for retired employees who retired prior to 01/01/2018 at the earliest'**

Seven years have passed. No orders are in sight. We are kept in dark. More than twenty thousand MTNL pensioners are frustrated. The disparity among the pensions of those retired before and after 01/01/2018 is untenable. **Therefore, we request your immediate intervention to correct this disparity and to uphold fairness**
