Sir this is a polite reminder to our letter dated 28th May'2025. We respectfully seek your personal intervention.

Earlier, DoT had intimated vide letter dated 05/11/2021 that **".this is a policy issue which is under active consideration of this Department and any decision in the matter is yet to be finalised"**. MTNL CO has also requested DoT vide letter No. MTNL/CO/IRW/21(82)/2015 dated 24/07/2024 that **'..it is once again requested to implement 5% IDA merger for retired employees who retired prior to 01/01/2018 at the earliest"**

Seven years have passed. No orders are in sight. More than twenty thousand MTNL pensioners are frustrated. The disparity among the pensions of those retired before and after 01/01/2018 is untenable. **Therefore, we request your intervention for immediate prompt issuance of the necessary orders to correct this disparity and uphold fairness.**
