**Sub: - IDA Neutralisation @73.8% in the pension of Pensioners retired before 01/01/18**

Sir would you kindly recall the assurance that was given in the meeting we had with your respected self on 14/10/2025 that "favourable orders will be issued, but it may take some time". Sir, we would again reiterate the following:-

1. The entitlements of the pensioners is absolute, not subject to, not restricted, not tainted by whatever "sharing arrangement is done between DoT and MTNL".
2. The pensioners have waited for unduly a long time, keeping patience.
3. Most of the aggrieved pensioners are super senior citizens around 80 years of age.

Therefore we respectfully request your kindness to cause to issue the orders on the following:-

1. Neutralisation of 73.8% IDA in the fitment of Pay on 01/01/2007 notionally and with payment of their pension from 01/01/2018 to those employees who were in service on 01/01/2007 but retired before 01/01/2018.
2. Neutralisation of 73.8% IDA in the fitment of Pension on 01/01/2007 notionally and with payment from 01/01/2018 to those employees retired before 01/01/2007.
