Respected Sir,

Sub:- To remove discrimination in the pension of those pensioners retired from MTNL before and after 01/01/2018.

Sir, We would request your kindness to hold a meeting with the office bearers of RTOWA Mumbai and RTOWA Delhi (Pensioners Associations of MTNL) to hear the stand of DoT from the Secretary as well as to apprise the views of the Pensioners to the Secretary in the following issue depriving the pensioners of their legitimate entitlement.

Our justified demands are :-

1. Fitment of pension with 73.8% IDA neutralisation, notionally from 01/01/2007 and with payment from 01/01/2018 to those pensioners as on 01/01/2007;
2. Notional Fitment of pay on 01/01/2007 of those employees who retired between 01/01/2007 to 31/12/2017 with IDA neutralisation of 73.8% and consequent recalculation of pension for payment from 01/01/2018.

This benefit of increased IDA neutralisation in the fitment of pay notionally on 01/01/2007 and with payment from 01/01/2018 has been given to those employees who were on service on 01/01/2018 and those pensioners retired after 01/01/2018. This has caused the discrimination.

We have been requesting for a meeting since last one year. In the past few months we had already met Addl.Secretary, Member (S), DDG (Estt) and all these officers had given positive assurances. However no orders are in sight.

The discrimination continues for more than seven years. We are kept in dark.

Sir the recent DO letter dated 09/07/2025 of Cabinet Secretary underlines that appointments by the Secretary of Ministries should be given to the Associations which will help to clarify the policies of the Government and will provide an opportunity to rectify mistakes if any.

Therefore we request a formal meeting on a convenient time and date of the Secretary.
