Respected Sir,

Sub:- Requesting to explicitly include the matter of 'Pension Revision of BSNL/MTNL pensioners on combined service' in the terms of reference of 8th CPC.

Sir, we, the Central Government employees absorbed en-masse in BSNL/MTNL are in receipt of retirement benefits from the Government. Our retirement benefits are on combined service as per Rule 37 of CCS Pension Rules 2021. Pension contribution is paid to Government by BSNL and MTNL for our PSU service.

The CCS Pension Rules'2021, in its entirety, apply to our retirement benefits in the same manner as they are applicable to the pensioners retired from other Central Government departments. We got all the retirement benefits as per the recommendations of 7th CPC with only exception of 'Revision of Pension'. The reason is that our "Pension Revision" matter was not explicitly included in the terms of reference of 7th CPC


Our entitlement to pension revision arises from the CCS Pension Rules which govern our retirement benefits entirely. Our pension governed by

the CCS Pension rules is not within the purview of PRC which is constituted for the pay and service matters of PSU employees.

Therefore we earnestly request that the matter of 'Pension Revision' of Government employees absorbed in BSNL/MTNL en-masse as per CCS Pension Rules and in receipt of retirement benefits on combined service from Government, be included explicitly in the terms and reference of 8th CPC.
