CIRCULAR

Subject : Submission of proof of savings for Income Tax Calculation/deduction purposes for the financial year 2024-25 (Assessment Year 2025-26).


Dear Pensioners,

All the Pensioners of O/o Pr. CCA Mumbai who are in receipt of Gross Monthly Pension exceeding Rs. 2,50,000/- are requested to furnish option / declaration if they wish to opt for old tax regime along with documentary proof of savings made during F.Y. 2024-25 duly categorized as per several sections of Income Tax Act, vide which the deductions are claimed for the financial year 2024-25 (Assessment Year 2025-26), latest by 10.12.2024 positively, failing which it will be presumed that the pensioner has opted for New Tax Regime and this office would not be responsible for any excess recovery being made. This will allow the DDO to process the necessary deduction and tax exemption before finalizing your income tax calculation.

The government of India Imposes an Income tax on taxable income of individuals. Levy of tax is separate on each of the persons. The levy is governed by the Indian Income Tax Act, 1961. The Indian Income Tax Department is governed by the Central Board for Direct Taxes (CBDT) and is part of the Department of Revenue under the Ministry of Finance, Govt. of India. Income tax is a key source of funds that the government uses to fund its activities and serve the public.

On the basis of the particulars furnished to this office, with necessary supporting documents, the total amount of Income-Tax will be calculated and the recoveries, if any, will be made from the pension for the months of December, 2024 to February, 2025. Pensioners are also requested to furnish the photocopies/Softcopies of documents before 10th December, 2024 in support of their savings. If savings details already submitted then need not to resubmit. Intimation received after due date (10.12.2024) will not be considered for tax calculation.
