#### Ministry of Law & Justice Department of Legal Affairs

#### Comp No. 100121

Department of Telecom (DoT) has sought advice of this Department on the feasibility of challenging the Order dated 20.09.2023 of Hon'ble CAT (PB), New Delhi passed in OA No 1272/2020 with OA No. 1271/2020 & 1329/2020 - seeking to revise pension/family pension/ minimum pension with effect from 01.01.2017 for BSNL/MTNL combined service pensioners.

- 2. Facts of the case have been mentioned by DOT in the referring note. The issue involved in the matter is regarding revision of pension of the retired pensioners of BSNL combined service employees. Contention of the retired pensioners associations/employees is that, as the pension of BSNL combined service employees is paid by Government and the pay of combined service employee is paid by BSNL, pension may be revised by the Government w.e.f. 01.01.2017 in the absence of any wage revision by BSNL. With this logic, some of the applicants approached to the Hon'ble CAT (PB), New Delhi for seeking reliefs.it has further been informed that Department of Pension & Pensioners 'Welfare, Department of Public Enterprises and Department of Expenditure are also cited respondents in these OAs. T
- 3. Hon'ble CAT in its Order dt. 20.09.2023 has observed and directed as follows -

"In view of the elaborate discussion above, the OA stands allowed. The competent authority amongst respondents is directed to forthwith revise the pension and family pension wherever applicable, strictly in accordance with the relevant rules and the entitlement governing pension to various sets of employees of the Central Government, maintaining strict parity. It is clarified that the benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the Pay Commission, shall stand extended in favour of the applicants, analogous to the revision of such pension in case of Central Government pensioners. The directions contained herein shall be complied with within a period of ten weeks from the date of receipt of a certified copy of this order."

- 4. We have gone through the reference. Government Counsels in the matters have opined that case is fit for challenge on the grounds stated in their opinion. DOT also intends to challenge the order on the grounds mentioned in the reference.
- 5. Rule 37 of CCS (Pension) Rules,2021 provides Conditions for payment of pension on absorption consequent upon conversion of a Government Department into a Public Sector Undertaking. Further, Sub Rules 26 and 27 of Rule 37 specifically provides about the combined service pensioners and read as-
  - 26) Nothing contained in sub-rules (18) to (25) shall apply in the case of conversion of the Departments of Telecom Services and Telecom Operations into Bharat

Sanchar Nigam Limited and Mahanagar Telephone Nigam Limited, in which case the pensionary benefits including family pension shall be paid by the Government. (27) For the payment of pensionary benefits including family pension referred to in sub-rule (26), the Government shall specify the arrangements and the manner including the rate of pensionary contributions to be made by Bharat Sanchar Nigam Limited and Mahanagar Telephone Nigam Limited to the Government and the manner in which financial liabilities on this account shall be met.

- 6. In view of the above, it is the domain of the Government to specify the manner in which financial liabilities shall be met in this regard. As per the referring Department the combined service pensioners are governed by Pay Revision Committee recommendations. Though, recommendations of the 3rd Pay revision committee has been implemented in most of the PSUs, it has not yet been implemented in the BSNL/MTNL yet, as the pay has not yet been revised, so there is no thrust to revise the pension of the retired employees.
- 7. Taking into account factual matrix of the case in hand and rule position in this regard, it seems to be a fit case for challenge. However, DOT may take decision in consultation with the Department of Pension & Pensioners' Welfare and Department of Public Enterprises being nodal departments on the issue in hand.

The undersigned is directed to refer to Department of Telecom's OM No. 38-52/2020-Pen(T) dated 27.09.2023 on the subject cited above. The matter has been examined in the Department and the comments of this Department are as under:-

2. It is observed that Hon'ble Tribunal, Principal Bench, New Delhi vide its Order dated 20.09.2023 in OA No. 1271, 1272 & 1329 of 2020 has allowed the OA (for revision of Pension of BSNL/MTNL pensioners) with following observations vide para 28 of its order dated 20.09.2023:-

"The competent authority amongst the respondents is directed to forthwith revise the pension and family pension wherever applicable, strictly in accordance with the relevant rules and the entitlement governing pension to various sets of employees of the Central Government, maintain strict parity. It is clarified that the benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the revision of such pension in case of Central Government pensioners."

- 3. Since, the Hon'ble CAT has ordered for revision of pension and family pension strictly as per relevant rules, it is for DoT to take an administrative decision in the matter. DoPPW has no further comments to offer.

Making any deviation in the existing criteria of pension fixation may have grave repercussions.
